ACTIVITIES OF KFCRI

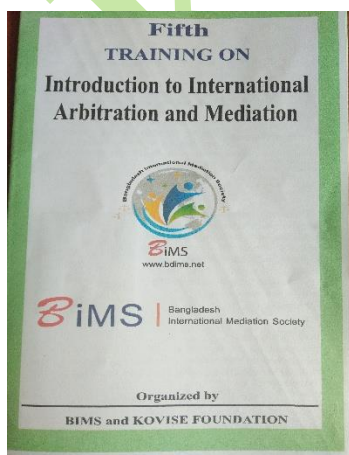
